



The Great Linseed Challenge

Aim

The aim of this competition is to identify and share best practice among UK linseed growers by encouraging farmers to submit details of their Harvest 2018 linseed crops to CPM and Premium Crops.

In return, the details will be considered by a panel of judges and assessed for;

- Net margin achieved per hectare
- Overall yield and
- Innovation in linseed agronomy.

Growers of both winter and spring linseed are eligible to enter.

Winners will be announced for each category and, from those an overall winner will be chosen.

The competition will be launched at Cereals 2017 and farmers can enter by submitting an entry form to Premium Crops.

The closing date for entries will be 31st May 2018.

A shortlist of candidates for each category will be announced at Cereals 2018 with the final Winners announced on the 1st June 2019

ENTRIES

Entry is Free of charge and the moment you submit your entry the processing of your entry commences.
